Treasurer, Dana Stempky commented on Cheboygan County Road Commission that all money was allocated for the year. She stated that there was over 1,000 hours of overtime during the snow storm in December.

Hall and bathroom design- Prints reviewed. The plans with the ramp going towards M-33 is the best design.

Comment by Ed Delana suggested that Planning and Zoning should review the plan for conformity, due to parking spaces. Chuck Maziasz will contact Architect, Richard Clements to verify if the plans were reviewed by Planning and Zoning before placing an ad for bids. The bid will be for the ramp, new entrance door, and bathroom remodel. Discussion that a new drain field is necessary, and will be a separate bid.

Road Improvement Agreement for Lakeland Dr. / Agnes Rd. and Pioneer Rd. / Mann Rd. – between Aloha Township and Cheboygan County Road Commission for an estimate of \$95,192 with a \$25,000 road allocation applied, minus the down payment. Project to be completed by October 1, 2023. Motion by Dana Stempky, seconded by Scott Eno to enter into Road Improvement Agreement. All ayes.

Board Representative for the Alverno Fire Department – Clerk, Teresa Sullivan who is currently on the AFD board would like to step down. Chuck Maziasz stated he is willing to step in with Scott Eno as an alternate. Motion by Dana Stempky, seconded by Scott Eno for new AFD Aloha Representative. All ayes.
